



OFFICIAL RULES

NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT INCREASE THE CHANCES OF WINNING.

1. **Sponsor:** KemperSports, Vidanta Resorts and SQN Escapes are each a "Sponsor" and collectively the "Sponsors" of the contest.
2. **Eligibility:** The jUno! Promotion (the "Contest") is open only to those who play a round of golf at a participating facility managed by KemperSports on the date of such round (each a "Facility") and who are age 21 or older as of such round. The Contest is only open to legal residents of the United States and is void where prohibited by law.
